Information and Explanation

The **Residual Value Lease Guide** contains the basic information needed to determine residual values.

HOW TO USE THIS GUIDE TO CALCULATE NEW VEHICLE RESIDUALS

- 1) Enter the MSRP of the vehicle to be leased or financed (SmartBuy).
- 2) Delete the MSRP of any equipment removed from the vehicle.
- 3) Add the amount of any dealer installed options that reflect added value, listed on page 12 - 13, to the MSRP to calculate the residuals.
- 4) Turn to the vehicle to be leased or financed.
- 5) Determine the residual factor for the appropriate lease term (12, 24, 30, 36, or 48 months).
- 6) Multiply the residual factor (line 5) times the total of lines 1 through 3 above.

Manufacturer's suggested retail price (MSRP) - The suggested retail price of the vehicle (including freight). Use the Gross MSRP before any discounts for equipment packages.

Mileage - The residuals in the guide are based on 15,000 miles per year (1250 per month). To adjust a residual for excess mileage see "Mileage Adjustment Formula" (page 6).

Odd Term Residual Calculation

Interpolate between the percentage for the nearest terms in the Residual Value Lease Guide and round downward if a fraction results. A minimum reduction of 1% will result.

EXAMPLE:

42 month contract term RVLG - 36 Mo. 48 Mo.
51% 46%

$$51 - (51 - 46) \frac{12}{6} = 48.5\% \text{ rounded downward}$$

Residual for 42 month transaction is 48%

25 month contract term RVLG - 24mo. 30 Mo.
59% 55%

$$59 - (59 - 55) \frac{6}{6} = 58.33\% \text{ rounded downward}$$

Residual for 25 month transaction is 58%

Insurance Requirements - SmartLease

Before a vehicle is delivered, the dealer must verify the following:

Public Liability Insurance – Minimum Coverage:

- \$100,000 Bodily Injury - per person
- \$300,000 Bodily Injury - per occurrence
- \$50,000 Property Damage - per occurrence

Commercial Use Vehicles over 10,000 GVW

- \$1,000,000 Umbrella Coverages PLUS minimums shown above
or
- \$1,000,000 Combined Single Limit for Bodily Injury and Property Damage - per occurrence

Physical Damage Insurance – Maximum Deductibles:

Collision Deductible

- \$500.00 Passenger Cars/Light Duty Trucks
- \$1,000.00 Medium Duty Trucks

Comprehensive Deductible

- \$500.00 Passenger Cars/Light Duty Trucks
- \$1,000.00 Medium Duty Trucks

Commercial Use Vehicles over 10,000 GVW

Physical Damage Deductible

- \$1,000.00

Unless instructed otherwise by the local GMAC branch, GMAC must be named as additional insured on the public liability insurance and as loss payee on the physical damage insurance.

Insurance Requirements – SmartBuy

Before the vehicle is delivered, the dealer must verify that the vehicle is covered under a physical damage insurance policy. GMAC must be named as the loss payee on the physical damage insurance.

Gap Protection

SmartLease offers GAP protection, which limits the lessee's liability when the vehicle is stolen and not recovered or totaled and there is an insurance settlement.

Security Deposit

A refundable security deposit is required with every SmartLease. The minimum security deposit should equal one Monthly Payment rounded to the next highest \$25.00. Contact the local GMAC Sales Purchase Office for information regarding current alternatives to this policy.

Used GM and New and Used Non-GM Vehicles

Residuals for eligible transactions can be obtained by accessing the RVLG On-Line at www.gmaconline.com

Commercial Use Transactions

Residuals in this guidebook (excluding the Commercial Vehicle Section) reflect percentages/values of vehicles based on personal use. Therefore, GMAC may evaluate each commercial transaction for potential excess wear and tear or mileage-related depreciation and may adjust residuals downward accordingly.

Mileage Adjustment Formula

Passenger Cars and Light Duty Trucks

Residuals are based on 15,000 miles per year (1,250 per month). Residuals for vehicles to be driven in excess of 15,000 miles per year must be reduced at the rate of \$.10 per mile (\$.15 per mile for new Cadillac transactions).

Example:

Customer estimates he will drive	1,500	miles per month
Lease Guide Allowance	<u>-1,250</u>	per month
Excess Mileage to be Charged	250	miles per month
Reduce residual on a 24 month transaction by \$600.00 (24 x \$.10 x 250)		

Under the Low Mileage Program the residual for vehicles to be driven in excess of 12,000 miles per year (1,000 per month) must be reduced at a rate of \$.12 per mile (\$.15 per mile on all terms for new Cadillac transactions). Vehicles to be driven over 13,200 miles per year (1,100 per month) are not eligible for the Low Mileage Program. The maximum term for the Low Mileage Program is 36 months.

SmartLease & SmartBuy

New Vehicle Eligibility

Eligible vehicles include the following:

1. New passenger cars (current and previous model year).
2. New light trucks up to 15,000 lbs. GVW (current and previous model year).
3. Certain current series new light truck conversions listed in this guide.
4. Certain medium duty trucks (including upfits) and conversion vans listed in this guide.
5. Prior Dealer Demos and HSDT Vehicles with up to 7,500 beginning miles.
6. Repaired Hail Damaged Vehicles (dealers should contact their local GMAC Branch office for guidelines).

Ineligible vehicles include the following:

1. Motor homes.
2. Vehicles equipped with special equipment.
3. Vehicles to be used for Driver Education (prior High School Driver Training Vehicles are eligible).
4. Emergency or Law Enforcement Vehicles.
5. Limousines.
6. Unrepaired Hail Damaged Vehicles.
7. "Branded" or "Lemon Law" Vehicles.
8. Frame Damaged Vehicles.
9. Non-GM Vehicles with terms of less than 24 months.
10. Compressed Natural Gas Vehicles.

Customer Eligibility

Businesses or individuals with a satisfactory credit history whose financial condition, credit and insurance qualifications support the terms included in a proposed lease.

SmartBuy programs are not available in all areas.

SmartLease/SmartBuy Programs

Single Payment Lease

A payment option for the SmartLease customer to pay all regularly scheduled lease payments upfront. The upfront payment may be less than the total of payments under a conventional SmartLease. All vehicles eligible for SmartLease are also eligible for the Single Payment Program unless otherwise designated.

Low Mileage Vehicle Program

SmartLease and SmartBuy customers expecting to drive 12,000 to 13,200 miles annually may be eligible for additional residual increases. Residuals may be increased 1.0 p.p. on contract terms of 24-35 months (2.0 p.p. for Cadillac transactions) and 2.0 p.p. on terms of 36 months. The residuals of vehicles driven over 12,000 miles (but less than 13,201 miles) annually will be reduced (See Mileage Adjustment Formula - Page 6). The Low Mileage Program is limited to new vehicles with contract terms of 24-36 months only.

New 2008 and 2007 Model Conversions for Sport Utilities, Vans, Suburbans, and Yukon XL

Only conversions completed by approved SVM upfitters are allowed. All conversion packages must be approved locally and be supported by a manufacturer's invoice detailing all options. The invoice must show net invoice cost to the dealer (i.e. dealer cost is net of after-sale rebates and/or upfitter incentives). The conversion package will be treated as a dealer installed option. The package may be residualized at 100% of dealer cost. The applicable deductions for converted units are listed under the standard residual for each eligible model. **Only those models with conversion deductions are eligible for residualization.** If applicable, deductions for *Manual Transmission, without Air Conditioning, and/or 20 Inch Factory Installed Wheels and/or 22 Inch Factory Installed Wheels* must be added to the deduction for conversion and the total subtracted from the standard residual when determining the appropriate residual percentage.

GM Employee/Supplier SmartLease/SmartBuy Program

The GM Vehicle Purchase Programs can be combined with the SmartLease and SmartBuy rates and residuals. Additionally, prior PEP Vehicles, with up to 25,000 beginning miles, will be considered eligible for all new vehicle programs unless otherwise designated.

SmartLease Payment Factors

SmartLease payment factors for selected terms and rates are provided to assist in the calculation of SmartLease payments. To calculate the payment: Locate the factors for the appropriate term and rate and apply these factors to the net capitalized cost and residual value, as shown in the following example:

Payment Calculation: 30 Months - 7.00% Rate

Net Cap Cost X Net Cap Cost Factor = Net Cap Cost Payment
 $\$30,000 \times 0.0362206 = \1086.62

Residual Value X Residual Factor = Residual Value Credit
 $\$13,800 \times 0.0302447 = \417.38

Net Cap Cost Payment – Residual Value Credit = Monthly Payment
 $\$1086.62 - \$417.38 = \$669.24$

New Commercial Vehicles

Upfitting

Upfitting will be treated as dealer installed options that add value and should be included on Line 3 of the Leasing Worksheet at no more than 115% (Light Duty) and 100% (Medium Duty) of dealer cost (i.e., dealer cost is net of after sale rebates or upfitter incentives). This must be approved locally and supported by an invoice from the Body Manufacturer. The specification of the Cab and Chassis must meet or exceed the requirements necessary for the installed upfit for a particular use. For any upfit not identified on this page, dealers should contact their GMAC Commercial Services Group (CSG) to determine eligibility. Vehicles exceeding 33,000 lbs. GVW are not eligible for SmartLease or SmartBuy.

The following upgrades to the cab and chassis are eligible:

1. Van Body
2. Stake bed
3. Flat Bed
4. Utility Bodies
5. Snow Plows * (Light Duty Only)
6. Refrigerator Bodies * (Medium Duty Only)
7. Dump Body * (On highway only)

*Contact your local GMAC branch office or Commercial Services Group (CSG) for restrictions.

Light Duty Transactions – SmartLease and SmartBuy

The following residual value percentages apply to Cab and Chassis and Cutway/High Cube transactions. The standard mileage is 15,000 miles per year. Residuals to be driven in excess of 15,000 miles per year must be reduced at the rate of \$.10 per excess mile. Light duty commercial transactions are eligible for the Low Mileage program.
